CODE OF CONDUCT FOR HOSTEL RESIDENTS

- 1 All residents are required to maintain standards of behavior expected of students of a prestigious institution of national repute. They are expected to behave courteously and fairly with everyone inside and outside the AIHM campus.
- 2. All residents are required to always carry their valid Identity Cards issued to them by the Institute.
- 3. The rooms, common areas and surroundings of the hostel should be kept clean and hygienic. Notices shall not be pasted on walls and walls shall not be scribbled on.
- 4. Students are responsible for the rooms which are allotted to them. They need to maintain their upkeep and hygiene.
- 5. Students should bring to the notice of the warden about any pending maintenance work (Civil, Carpentry, Electrical, Sanitation) to be carried out in rooms, corridors, toilets or other areas in hostel premises.
- 6. Students should co-operate in carrying out maintenance work and vacate their rooms completely when the Hostel administration requires the rooms for this purpose. If any maintenance work is to be carried out when the room is under occupation, it is the occupant's responsibility to make the room available for the maintenance work.
- 7. The students should not carry unauthorized/illegal objects in their rooms. Any violation will be dealt severely.
- 8. The resident of a room is responsible for any damage to the property in the room during his / her occupancy of that room and will be required to replace/repair at their own cost the damage, if any.
- 9. In case of damage to or loss of hostel property the cost will be recovered from the students

responsible for such damage or loss, if identified, or from all the students of the hostel, as decided by the authority.

- 10. The resident shall not move any furniture from its proper allotted place and also not damage them in anyway. If there are any additional items other than the above belonging to the hostel in a room, the occupant of the room shall hand over them to the warden/authority & the items will be ceased by the warden, failing which he/she will be charged a penalty as decided by the authority.
- 11. The resident shall not remove any fittings from any other room or common area and will not damage them.
- 12 . Ragging of students admitted to the Institute is totally banned. Any violation of this by the senior students will be dealt with very severely as per the Institute norms and guidelines issued from time to time by the competent authorities.
- 13 Students should report incidents of ragging immediately. Those who do not do so even when being witnesses or victims, will be considered to be part of this practice, and will also be punished accordingly.
- 14 When the persons committing or abetting the crime of ragging are not identified, collective punishment on suspected group could be resorted to as a possible deterrent measure, as it would ensure community pressure on the potential raggers not to indulge in ragging.
- 15. In the hostel premises following are strictly prohibited -
 - Smoking
 - Consumption of alcoholic drinks/drugs
 - Gambling
 - Intimidation or violence
 - Willful damage to property
 - Entering the hostel premises in intoxicated state.
 - Moving near outside hostel premises after 9.00 pm.
 - Shouting and using abusive language in their own room, hostel premises and campus.



- Employing unauthorized persons for personal work such as washing clothes, etc.
- Cooking in room.
- The use of electrical appliances such as immersion heaters, electric stove, electric iron, kettle, heater etc' are not allowed in the rooms. Such appliances, if found will be confiscated and a fine will also be imposed.
- The uses of audio systems which may cause inconvenience to other occupants are not allowed. The students should not view objectionable videos.
- 16. Carrying food/food plates from mess is strictly prohibited in rooms. However in case of illness permission of warden is required.
- 17. Residents should not participate in any anti-national, antisocial or undesirable activity in or outside the campus.
- 18. When the students go out of their room they should switch off all the lights & fans. keep it locked. Violation will attract suitable penalty and punishment as decided by authorities.
- 19. Students must take permission from wardens for going out from the hostel for any reason and must make entry in the in-out register available with security guards at the hostel gate. Violation of this rule may lead to disciplinary action including expulsion from the hostel.
- 20 All residents of girls' hostels must be back in the hostel by 7.00 PM. & Boys must be back by 8.00 PM.
- 21. If student needs to stay out of the hostel after specified time due to any reason. He/she has to apply for and take prior written permission from the Senior Warden/authorities. Violation of this rule may lead to disciplinary action including expulsion from the hostel.
- 22. Students moving outside the hostel premises are responsible for their own self. Management is not responsible for any untoward happening with the students.
- 23 Any physical damage done by the student to himself or others will be the responsibility of the student only. Management will not be liable for any such acts.
- 24. If students create law and order problems inside or outside the campus, they are answerable

to the police or city administration on their own. In such cases, they will also be answerable to AIHM administration as per the institute norms.

- 25. Residents are required to park the vehicles only in the space provided for them in an orderly manner. No vehicles should be parked near the entrance or in the corridors.
- 26. The residents of the hostel are responsible for the safe keeping of their personal belongings. Management will not being responsible for it.
- 27. Students are required to adhere the mess timings strictly and also directed to follow dinning etiquettes.
- 28. Students are directed to submitted all the hostel belongings to the warden before vacating the hostel at any time.
