Sub: Common Fee structure for the batch 2020-21 for B.Sc. Hospitality and Hotel Administration program.

Sir/ Madam,

This is regarding the common fee structure for collection of fee for academic session 2020-21, it is to inform you that all affiliated Institute of Hotel Management may collect Second and Third Year Fees as per the details given hereunder. For collection of the First Year fee, as soon as it is finalized will be informed accordingly. Details of Fee Structure Semester-wise for academic session 2020-21 is given hereunder:

**\*Note:** - The above is a common fee structure for all the IHMs. However the cities in India has been divided in three categories according to the status of the city in which the IHMs are located and given discretion of charging higher tuition fee to the IHMs located in first two category of cities. The categorization of the cities and the discretion of charging increased tuition fee is as under :-

Category	Cities where the IHMs are located	Maximum discretion allowed to the respective Board of the IHM
"A"	Delhi, Mumbai, Kolkata, Chennai, Bengaluru and Hyderabad	Maximum up to 25% in the Tuition fee component only.
"B"	Gandhinagar, Jaipur, Lucknow, Bhopal and Chandigarh	Maximum up to 15% in the Tuition fee component only.
"C"	Rest of the cities where the IHMs are located	No discretion

Institute should follow the instruction issued by Hon'ble Apex Court of India in this regard that none of the Institution can increase fee over and above the declared fee structure for the existing batches. Therefore, even if the Institute get NOC for increased fee structure, that will not be applicable for existing batch in Third Year (5<sup>th</sup> & 6<sup>th</sup> Semester).

Fee Structure of B.Sc.HHA has already been mentioned in the Information Brochure 2018,2019,2020 : -**Enrolment Fee** (one time) and **Examination Fee (50%)** collected from the students will be payable to NCHMCT as given below:



Fee towards IGNOU components for **Second Year Rs.12700 & Third Year Rs.12700/-** are to be collected from students and a consolidated fee send through RTGS mode or through demand draft in f/o IGNOU payable at New Delhi along with list of candidates with their roll number(Council's Roll Number separate for Second year and Third Year) may be sent directly to IGNOU and copy to NCHMCT for information.

The sharing of examination fee with NCHM and IHMs reviewed in the ratio of 50:50 as approved in NCHMCT 48<sup>th</sup> BOG meeting. Hence, Examination Fee collected for all Courses, **50%** may be retained by the Institute towards conduct of Annual Examination both (Theory & Practical) and remaining 50% be remitted to **NCHMCT** through RTGS mode or through demand draft in f/o NCHMCT, payable at Noida along with list of students (Courses wise) by the end of each Semester/ Term. **While sending fees of any kind through RTGS to NCHM, UTR Number/ Ref.
