SUBJECT:-SCHOLARSHIP SCHEME FROM NCHMCT, NOIDA AND AIHM CHANDIGARH FOR THE YEAR 2021-22 ON MERIT CUM MEANS BASIS FOR ALL CATEGORIES.

Merit cum Means basis Scholarship shall be provided to **One student of 2nd Semester and 6th Semester of Three Year B.Sc. in Hospitality & Hotel Administration Programme (on the basis of exam held in the month of November, 2021 & February, 2022), WHO OBTAINED THE HIGHEST PERCENTAGE OF AGGREGATE MARKS IN THEIR SEMESTER (minimum being 60%) in the 1st Semester, & 5th Semester examination respectively and the student whose parent's Gross Annual Income from all sources is below 3 Lacs.** Such students are hereby directed to download the "form" from Institute website with regard to grant of financial Assistance to the Students on merit cum means basis and send the duly filled form along with supporting documents through speed post **latest by 31-07-2022.**

Following Documents are required to be submitted along with the format:

1. The Student will have to submit an AFFIDAVIT on non-judicial stamp paper of Rs. 10/- (Rupees Ten only) as declaration from their parents regarding:
 - Occupation of the father and mother of the applicant.
 - Declaration of Income of Parents from all sources which should not exceed 3 Lacs per annum.
 - That the applicant/ward has not been receiving any financial assistance support / Assistantship from any State/Central Govt. Institutions/ Organizations for pursuing the studies for which he/she is enrolled in the affiliated institute.
2. Marksheets of related Semester examination/JEE Rank result.
3. Caste Certificate (in case of reserve category i.e. OBC/SC/ST)
4. Valid Income Certificate issued from competent authority (not more than one year old)

Under the above mentioned scheme Only 50% of the Tuition fee of Semester shall be provided to one student of each semester by NCHMCT and AIHM Chandigarh jointly, Remaining 50% of the 'Tuition Fee and other fees shall be borne by the students who fulfil the above mentioned criteria. Any false and untrue declaration may lead to rustication from the Institute and initiate judicial procedure against them.

The grant of financial assistance to the students should not be taken as claim, as it is subject to fulfilment of conditions.
